

## Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 5 May 2015 and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 5 September 2016 and 9 September 2016 acquired no. 2,384 treasury shares at an average unit price of € 9.1423 per share, for a total amount of € 21,795.14.
